**ORDER**

SAFI Institute of Advanced Study (Self - financing), Vazhayoor East, Ramanattukara, Malappuram, has submitted proposal for conferment of autonomous status through the University Grants Commission's online portal. Considering the request of UGC to review the proposal and forward the recommendation of the University, an inspection team was constituted vide University Order read as (1), to assess the eligibility of the College for autonomous status. The recommendation of the inspection team has been considered and approved by the Syndicate vide paper read as (2).

2. The University Grants Commission vide paper read as (3), has communicated its decision to confer autonomous status to SAFI Institute of Advanced Study (Self - financing), Rasiya Nagar, Vazhayoor East P.O, Via Ramanattukara, Malappuram, Kerala affiliated to University of Calicut for a period of ten years from the academic year 2024-2025 to 2033-2034, as per Clause 7.5 of the University Grants Commission (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 and requested the University to issue necessary notification in this regard.

3. Considering the matter, the Vice Chancellor has ordered to place the matter before the Syndicate. The Syndicate, vide paper read as (4), has resolved to approve the UGC decision to grant autonomous status to SAFI Institute of Advanced Study (Self - financing) for a period of ten (10) years from the academic year 2024-2025 to 2033-2034 and to issue necessary notification.

4. Sanction has been accorded by the Vice Chancellor to implement the above resolution of the Syndicate.

5. Therefore, SAFI Institute of Advanced Study (Self - financing), Rasiya Nagar, Vazhayoor East P.O, Via Ramanattukara, Malappuram, Kerala, is granted autonomy for a period of ten (10) years from the academic year 2024-2025 to 2033-2034, in compliance with the UGC decision.
