ORDER

SAFI INSTITUTE OF ADVANCED STUDY(Autonomous), Rasiya Nagar, Vazhayoor East P.O, Ramanattukara Via, Malappuram submitted application vide paper read (1) for starting the following self financing four year ITEP programmes, namely BA B.Ed and B.Sc B.Ed from 2025-26 academic year onwards.

in the said college as detailed below:

The College submitted the Syllabus for the 4 year ITEP (Integrated Teacher Education Programme). It was informed by the General and Academic branch that necessary steps will be taken urgently for the scrutiny of the syllabus submitted by the above college and the eligibility conditions for admission, subject to the recommendations of the ITEP Committee and the approval of the BoS, and that the regulations of the 4-year ITEP (Integrated Teacher Education Programme) programs have been implemented in the university vide the university order read (3).

Considering the application of the Principal, a committee comprising DLIC and subject experts was constituted to inspect the college vide U.O. read as (4).

The committee, which visited the college on 25.08.2025, recommended that the above 4-year ITEP self-financing programs be started from the academic year 2025-26 and offered remarks on certain defects and further necessary steps to be taken for the smooth implementation of the programs before the commencement of Programmes.

The University recommended to the Higher Education Department for the sanction of the above mentioned 4-year ITEP programmes at Safi Institute of Advanced Study (Autonomous) College, vide letter read (5).

As per the letter read (6), the college was asked to implement the recommendations of the Inspection Commission and submit the documents of its implementation. Vide the letter read (7), the College Principal has submitted a declaration that all the conditions as per the Inspection Commission report have been implemented along with documentary proof.

The Standing Committee on Finance has been entrusted with the preparation of the fee structure for ITEP programs vide item No. 2025.1067* dated 02.09.2025 read (8) and the above decision has been implemented vide UO read as (9). The fee structure of ITEP programs has not yet been finalized. The college has submitted an undertaking stating that if there is any shortfall in the amount paid, it will be paid as per the fee structure of the 4-year ITEP program as decided by the Syndicate.

Based on the undertaking on fee to be remitted, the affidavit prepared on stamp paper worth Rs. 200/- dated 28.01.2025, Administrative Sanction from the government as per G.O. read (10), NOC from the Government as per read (11), the Vice Chancellor in exercise of the powers vested in the Vice Chancellor under section 10 (13) of Calicut University Act 1975, approved the above request to grant Provisional Affiliation to the following Self Financing 4 year ITEP (Integrated Teacher Education Programme) Programmes at Safi Institute of Advanced Study (Autonomous), Vazhayur, Ramanattukara, Malappuram, for the academic year 2025-26, subject to the approval of the Syllabus.

- The college has to remit the annual processing fee fixed by the University.
- The Educational Agency/College shall abide by the conditions stipulated in the NOC and NCTE with regard to the procedure of admission, collection of fees and other Regulations.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort is compulsory and binding on all colleges affiliated to the University of Calicut.
- In the light of the directions of Supreme Court of India in WP (C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted to the college will automatically be cancelled.

Violation of above may lead to cancellation of affiliation.
