**ORDER**

The SRC vide Order No. F. No. NCTE/SRC/ 2526202404232215/ KERALA/2024/ Recognition Order dated 06.06.2025 has granted recognition to **Safi Institute Of Advanced Study (Autonomous), Ramanattukara, Vazhayur, Kondotty, Ramanattukara, Malappuram, Kerala-673633** for the following ITEP Courses from the Academic Session 2026-2027.

Aggrieved by the decision of SRC in granting recognition for the academic session 2026-2027, the institution approached the Hon'ble High Court of Kerala in WP(C) No. 21194 of 2025 and the Hon'ble High Court vide its order dated 27<sup>th</sup> June 2025 has directed as under :-

*"The present writ petition is allowed in terms of the interim order dated 11.06.2025. The National Council for Teacher Education (NCTE) is directed to include the petitioner's institution in list of eligible Institutions for allotment of students for the Integrated Teacher Education Programme (ITEP) for the Academic Year 2025-26."*

3. AND WHEREAS, the NCTE-HQrs had considered the matter and directed to adhere to the directions of the Hon'ble High Court of Kerala in W.P. No. 21194/2025.

4. AND WHEREAS the matter was considered by SRC in its 466<sup>th</sup> meeting held on 16<sup>th</sup> July 2025 wherein the SRC decided as under :-

*On careful perusal of the original file of the institution, NCTE Act, Rules, Regulations, directions of the Hon'ble Court, directions of NCTE-HQrs and guidelines of NCTE-HQrs published from time to time, the SRC decided that the Session mentioned in the Recognition order dated 06.06.2025 to SAFI INSTITUTE OF ADVANCED STUDY (AUTONOMOUS), RAMANATTUKARA, VAZHAYUR, KONDOTTY, RAMANATTUKARA, MALAPPURAM, KERALA-673633 be read as 2025-2026 instead of 2026-2027 for ITEP B.Sc. B.Ed. Secondary (1 unit); B.A. B.Ed. Secondary (1 unit).*

*The order with regard to this be issued immediately."*

4. Now, therefore, as per the decision of SRC, the institution i.e. **Safi Institute Of Advanced Study (Autonomous), Ramanattukara, Vazhayur, Kondotty, Ramanattukara, Malappuram, Kerala-673633** is hereby granted recognition for the following ITEP Courses from the academic session 2025-2026 under clause 7(16) of NCTE (Recognition Norms &

Procedure) Regulation, 2014 as amended from time to time, subject to compliance of the directions mentioned in the Recognition Order dated 06.06.2025 referred above.
